- Angie Stinson w/Carver County presented the Private Access Policy Regarding a new private access on to a county road.
- SFT board members asked for the County meeting to be moved to March versus February 21st to allow time to review and approve the new policy and provide comments.

Road & Bridge Report

- Process for addressing mailbox damages due to plowing
 - Township will replace damaged mailboxes with swing away mailboxes if damaged. (Township purchased 12 currently to test the process.)
 - Scott made a motion to replace damaged mailboxes with the swing away at the township's cost. Larry Seconded, all in favor. Motion passed.
- Grading Bids
 - The board has been fielding complaints over the past couple of years about the road grading. Bids for the upcoming year were requested by Andy. He got a bid from Ron Olson (\$148/hour) construction and Josh at Digrite (\$155/hour).
 - Scott made a motion to give Digrite a try, Andy seconded. Larry opposed. Motion passed.
- Plowing across the road Statute reminder
 - \circ $\;$ Heidi created a postcard to notify anyone not adhering to the guidelines.
 - Scott made a motion to send the reminder postcard to residents who are not adhering to it. Larry seconded. Motion passed.
- Cable depth in the road Right of Way

Citizens Committee

- Phase 2 Rehabilitation discussion. Phil Solseng gave a presentation including the history of the effort.
 - Focus on code compliance and functionality as a public building.
 - Heidi reviewed the survey responses from the survey's
 - 77 percent cited the township should continue the work to improve the inside.
 - Sue Palmquist reviewed the bathroom proposal.
 - Costs summary: pre-approved \$84,721 matching funds have not been spent yet.
 - \$34,721 would be available after egress and ramp/lift completion costs.
 - \$88,451 ARPA funds available
 - \$123,172 total funds available
 - Peter Ivy r gave summary in support for moving forward.
 - Insurance company would let it be rented out.
 - Claudine Solsang gave overview on improvement positives
 - 1917 building built to replace previous building that burned down,

 - There are high school volunteers from Southwest Christian school who would help remove the tires on the top of the pile in April.
 - Larry will check with the township lawyer to determine if there was any liability to the township.
 - Scott made a motion that the township will pick up the tires once they are moved to an accessible spot on the property. Andy seconded. Motion carried.
