Reviewed meeting minutes from March Monthly Township meeting.

- Larry made motion to approve, Andy seconded. Motion passed.

Treasurer's report

- Township accounts = \$ 188,893.93
- CDs: \$493,034.40
- Grant account = \$2,759.82
- ARPA account = \$88,451.24
 - Andy made a motion to approve, Larry seconded. Motion passed.

Planning and Zoning

- Roger Falkenstein – presented final plat for a proposed development. Does not need a notary as it was already approved.
 - Andy made motion to approve a second time, Larry seconded. Motion passed.
- Kurt Ohnsorg – New shed variance – Postponed - waiting until next month's meeting to review.

Road & Bridge Report

- Reviewed quote from Tom Chard on mixed class 5 and milling chips (ground asphalt). Price is comparable as the price for Limestone. Quote is good for a year. Per Tom Chard, product is not currently made so would like advance warning when the township will want to use some.
 - Township will be looking at trying the product on some roads close to the Chards.
- Per Andy they had a road review on 4/12. Discussed suggestions for fixing the shoulder edges so there is not such a lift. Josh with Digrite suggested they could use a disk to work the material into the road before the grass grows.
 - Larry made a motion to have all the roads disked as soon as possible. Andy seconded. Motion passed.
 - Discussed road improvements on 187th.
 - Need minutes from road review – Andy to forward to Jeanne.

Citizens Committee

- Scott Selken plan for attached bathroom to be discussed in May. Sue Palmquist has adapted the original plan presented to accommodate Scott's idea.
- May 5 at 1:00 p.m. they will review the punch list of remaining work be done with Todd Grover at the Schoolhouse. Can finalize the report then.
- Last November the committee was interviewed on the schoolhouse improvements and the article has now been published.

New Business

 - Contamination notification sent to anyone near the creek.

- Two residents that reside in a development on Halsey asked about buying rock at the township's cost. Heidi expressed that this should be run by MAT to ensure there is no conflict.
 - Andy made a motion that, if MAT advises this is acceptable, the township can work with the owners to provide the information. Larry seconded. Motion passed.
