Road & Bridge Report

- Mixed class 5 and milling chips (ground asphalt)
 - o Andy talked to the company and they will be putting down the milling chips next week.
- Dead end signs that were down have been replaced.
- Joyce Rd engineer update
 - Matt w/Stantec attended and spoke regarding the proposal for opening guard rails. He said he would look at how to achieve this with minimum impact to area as well as cost.
 - Soil borings would be needed. The cost estimate for that would be less than 20K. The
 total cost for Engineering would be around 50K. He suggested it should be completed
 by the middle of October and would be a 6-week project. In summary, it would be
 difficult to get this all done this year realistically plus it is not an emergency.
 - Would be 26' between face of guard rails.
- Andy stated that there is no rush. There are two entrances into the area so anyone with large equipment can go around. If it comes down to a safety issue the road can be closed.
- Total overall cost of 300 400K estimated for the project.
- A resident commented that there is low likelihood that cars would meet there and a "Narrow Bridge" sign would suffice.
- Andy made a motion to table the effort. Scott seconded. All in favor. Motion passed.

Citizens Committee

- Discussion occurred regarding closing stabilization Grant / Foundation repair.
- The contractor will share foundation repair assessment.
- Larry reached out to the person with the ramps for sale that he spoke with last month. The cost would be \$17,800 for 50 feet. A used ramp would cost \$13,200. Discussion was that it would be put on the east side of the building. Cost does not include installation or building modification.
- Continued discussion occurred regarding the bathroom versus ramp coming first.
 - o 3 letters have been received by the township in favor of the Phase II project
- Andy made motion to table the ramp discussion until the foundation is squared away. Scott seconded. All in favor. Motion passed.
