- The township is still owed 35K from Historical Society. Supervisors agreed that the bills submitted by Todd (consultant) and Jerry (contractor) should be paid from the general fund and reimbursed when the grant closes and provides final payment.
- Ron Olson escrow bill outstanding due: \$4,124.00 to be discussed in January. A
 letter was received by the township from a resident expressing the opinion that
 according to the Ordinance they should not be waived or split.
