Reorganization:

- ☐ A new Treasurer will need to be appointed. Decided to ask Jeanne as deputy clerk to also take over the treasurer. Heidi and Jeanne can assign duties as agreed for the two positions.

Motion was made to pay the clerk the same pay rate as the Supervisors. The treasurer will be paid \$330/bi-yearly for general accounting and the same rate as Supervisors for additional work. 2nd. Approved.

- □ SFT currently banks at Old National in Chaska. Motion to continue banking there was made in January when CD rates were discussed. All investment funds are in one CD at 4%. Funds can be withdrawn as needed. CD will automatically renew.
- □ Larry motioned to use the Chaska Herald and the website as our official place of posting notice. 2nd. Approved.
- ☐ Monday agenda deadline has proved difficult. Posting an agenda is not mandatory and done as a curtesy to residents.

Scott motioned to remove the time and addition restrictions on our posted agenda. 2nd, approved. The clerk will post a "proposed agenda" on the website before the meeting

Financial

- □ Board reviewed and discussed the financial statement for 2022 provided by the clerk. Assessing amount was questioned and found in error. Established that all bills are paid and current.
- 2022 Levy was compared to actual expenditures

Scott moved to accept the 2022 Financial statement. 2nd. Approved.

☐ The Levy for 2024 was reviewed compared to historical levies. The budget for Grading and plowing was increased. Other small adjustments were made.

Larry motioned to propose a 2024 levy of \$420,700 to the residents at the annual meeting. 2nd Approved.
