

**NOTICE OF FILING FOR THE 2022 STATE GENERAL ELECTION
CARVER COUNTY, MINNESOTA**

Notice is hereby given that a general election will be held in Carver County on Tuesday, November 8, 2022, for the purpose of electing candidates for the offices listed below. The filing period for these offices begins at 8:00 a.m., on Tuesday, May 17, 2022, and ends at 5:00 p.m. on Tuesday, May 31, 2022. Candidates may file in person or by mail. Candidates who will be absent from the state during the filing period may arrange to file, in person, prior to departure. Because May 30th is a state holiday, neither affidavits of candidacy nor nominating petitions will be accepted for filing and will not be processed on May 30th, 2022. Nominating petitions may, however, be circulated and signed on May 30th, 2022.

Please note that this notice is based on current law. Be aware that the Legislature and/or the Governor may take actions that could affect some of these processes.
