## SAN FRANCISCO TOWNSHIP NOTICE PUBLIC HEARING

SAN FRANCISCO TOWNSHIP PLANNING COMMISSION SAN FRANCISCO TOWNSHIP CARVER COUNTY, MINNESOTA NOTICE OF PUBLIC HEARING NOTICE IS HEREBY GIVEN that the San

Francisco Township Planning Commission will hold a public hearing on May 12, 2022 at 6:00 p.m., at Carver City Hall, 316 Broadway, Carver, MN 55315, for the purpose of hearing from the public, considering, and taking action on a recommendation to the Town Board regarding the application submitted by Ron Olson and Ron Olson Construction LLC for an interim use permit for a mineral extraction operation located in the area of Joyce Road and 159th Street in Section 4 of the Town. The proposal is to establish a sand and gravel mining operation on 37 acres of property, conducted in four phases, including mining, screening, crushing, recycling concrete and asphalt and site restoration, with no more than 10 acres of active mine area, 15 acres of operations area and 10 acres of active restoration area at any given time. A copy of the application is posted on the Town's website.

Interested persons are encouraged to attend the hearing or to submit written comments to the Town Clerk prior to the hearing.

#### TOWNSHIP HALL REHABILITATION

Contractor, Equity Builders, has mobilized and is working on the masonry construction (chimney and building). The windows have been removed and are being restored. Concrete work on the foundation, work on the cupola and doors, and other miscellaneous work are expected to be completed by the end of June. Nearby neighbors, Glenn and Harri, removed the handicap ramp temporarily for the masonry construction.
